# My Career Dashboard.com Terms of Service

# Effective as of January 1, 2018.

Career Innovations Inc ("Mycareerdashboard.com, "we," "us," "our," "Company") provides certain services (as described below) to you through its website located at www.mycareerdashboard.com (the "Site"), subject to the following Terms of Service ("TOS"), which may be updated by us from time to time without prior notice to you. You should periodically visit this page to review the current TOS so you are aware of any revision to which you are bound. BY USING THE SITE AND ITS SERVICES, YOU AGREE TO THESE TERMS OF USE; IF YOU DO NOT AGREE, DO NOT USE THE SITE.

In addition, when using certain services, you shall be subject to any additional terms applicable to such services that may be posted on the Site from time to time. All such terms are hereby incorporated by reference into the TOS.

# **Your Privacy**

At mycareerdashboard.com we respect the privacy of our users and we will not share your contact information with any affiliate or third party, except when required to do so by law.

# Which information we may collect on our Users?

We collect two types of data and information:

A. **Non-personal Information** – The first type of information is non-identifiable and anonymous information ("**Non-personal Information**"). To put it simply, we have no idea what is the identity of the User from which we have collected the Non-personal Information. Like most websites on the Internet the Non-personal Information which is being gathered consists of technical information and behavioral information, as detailed below:

## Behavioral information:

- User activity such as log-ins, number of applications tracked, and date/time of access.
- Overall, impersonal statistical information regarding total amount of logins and apps tracked, whether you signed up for calendar reminders, and friend referrals.

Please note that in order to collect the **Non-Personal** Information we may use common third party analytics services such as: <u>Google Analytics</u>, <u>Facebook Insights</u>, etc.

B. **Personal Information** – The other type of information is individually identifiable information ("**Personal Information**"). To put it simply, this information may identify an individual or is of a private and/or sensitive nature. Personal Information which is being gathered consists of any personal details provided <u>voluntarily</u> by the User (e.g. User's name, email address, resume, etc.) mainly by registration to the Service and/or sync services of such Personal Information on our Service. We also respect and treat any email you may send to us as Personal Information. **To avoid confusion**, rest assured

that any Non-personal Information combined with Personal Information shall be regarded as Personal information. We will not collect any Personal Information from you without your approval. We will only share information about you, such as your resume with prospective employers, if you have given us explicit permission.

#### The Service

# **Description of Service:**

Mycareerdashboard.com provides users with online application tracking and career development services through the Site and its related services, whether accessible via personal computer, mobile and wireless devices or otherwise (together with the Site, the "Service").
